

# Akshay Kumar Sells 2 Mumbai Apartments For Rs 7.1 Crore



**Mumbai, 4 June:** Akshay Kumar has reportedly sold two apartments in Mumbai for a combined Rs 7.1 crore. According to reports, both units are located in the Oberoi Sky City complex in Borivali East.

As per property registration documents accessed by CRE Matrix, the larger apartment is located on a higher floor and has a carpet area of 1,101 sq ft. The property was reportedly sold for Rs 5.75 crore. The transaction included a stamp duty payment of Rs 28.75 lakh and two car parking spaces.

The documents further revealed that the second unit, situated on the same floor, has a carpet area of 252 sq ft. It was sold for Rs 1.35 crore, with the buyer paying Rs 6.75 lakh in stamp duty. The transaction also included one parking space. According to reports, both transactions were registered on June 2, 2026, and the properties were purchased by Suvarna Rupeshkumar Sakpal.

Akshay Kumar's Real Estate Deals This is not the first time the Bollywood star has sold a property within the Oberoi Sky City project. Over the past few years, Akshay Kumar has been steadily offloading several of his real estate investments in Mumbai. According to a LinkedIn post shared by Square Yards, the actor sold an apartment in the development for Rs 4.35 crore in March last year.

Akshay had originally purchased the property in November 2017 for Rs 2.37 crore, resulting in an impressive 84 per cent appreciation over a seven-year period. The apartment measures 1,073 sq. ft. and comes with two dedicated car parking spaces. The transaction attracted a stamp duty of Rs 26.1 lakh and registration charges of Rs 30,000.

The Square Yards post further revealed that Akshay Kumar sold another apartment in the same residential project in January 2025 for Rs 4.25 crore.

The actor was last seen in Bhooth

Bangla, directed by Priyadarshan. Up next, he will appear in Welcome to the Jungle, releasing on June 26.

# Camila Cabello, Henry Junior Chalhoub Call It Quits After 18-Month Romance



**Mumbai, 4 June:** Singer-songwriter Camila Cabello and billionaire businessman Henry Junior Chalhoub have reportedly ended their relationship. The "Havana" hitmaker, 29, and the 40-year-old billionaire heir have parted ways after nearly 18 months of dating.

The reported split comes after a relationship marked by luxury getaways, public appearances, and several high-profile sightings. Throughout their time together, the couple largely kept their romance low-key while occasionally stepping out together at major events and destinations around the world.

Camila Cabello Splits From Billionaire Boyfriend Henry Junior Chalhoub According to reports, the relationship came to an end after the couple realised they were heading in different directions. There was no major fallout or public drama surrounding the split. Instead, it appears to have been a

mutual decision, though the news has left many fans surprised.

As per The Sun, a source revealed, "Camila and Henry had an honest conversation and came to the conclusion they should end things. They had a lot of fun together while it lasted but it wasn't meant to be. It's quite raw but they are both going into the summer as singletons."

The couple was last spotted together in public at the Coachella Valley Music and Arts Festival in April. While their romance generated a lot of interest from fans and media outlets after they were first linked in 2024, Camila and Henry mostly kept things private.

The two reportedly met at an Elie Saab fashion after-party in Saudi Arabia and were later seen together on several occasions, including lavish holidays in St. Barts and Ibiza. During their trip to Ibiza, the pair was also photographed

sharing a passionate kiss on a dock as she leaned against him.

Despite dating for over a year, the pair made only a few public appearances together and rarely spoke about their relationship. They preferred to keep their romance away from the spotlight, even as fan interest continued to grow. As of now, neither Camila nor Henry has publicly reacted to the reports of their breakup.

Before dating Henry Chalhoub, Camila Cabello was in a high-profile on-and-off relationship with singer Shawn Mendes. The former couple briefly rekindled their romance before ultimately calling it quits in June 2023. Prior to Mendes, Cabello was also linked to life coach Matthew Hussey.

Over the years, the singer has made it clear that she prefers to keep her personal life away from the spotlight. Speaking to Latina magazine in 2017, Cabello shared, "I get why people are interested in my love life, but I don't want to give people that piece of me because it is the most important part."

The singer also spoke about the kind of life she envisions for herself, saying, "I want to make songs and have incredible experiences with people. I don't want to be locked up in a hotel room and just do press and red carpets. That's not the kind of life I want to live."
