"Don't Know Who's Getting Married": Rachit Singh Shuts Down Wedding Rumours With Huma Qureshi

Mumbai, 17 July: Actor Rachit Singh, who shared screen space with Huma Qureshi in Baby Do Die Do, has addressed rumours about his wedding to his co-star. The duo has been spotted together at public events, posing for the paparazzi and fuelling speculation about their reported romance. Reports claiming that they were planning to tie the knot in October or November this year have surfaced, but the actor has now put all such rumours to rest.

Speaking to Hindustan Times, Singh laughed off the speculation and said, "Pata nahi kaun, kaha meri marriage kara raha hai (Don't know who's getting me married where)." Amused by the buzz, he added, "Main soch raha hun apni mummy ka number de dun. Sab log mujhe phone kar ke puch rahe hai. It's not happening (I am thinking about giving my mother's phone number. Every-one's calling me and asking)."

Rumours about Huma Qureshi and Rachit Singh's relationship gained momentum after the two were spotted to-gether at a celebrity wedding reception.

Their public appearances later only fu-elled the dating rumours, with reports eventually suggesting that the actors were planning to get married later this year. During the promotions of Baby Do Die Do, Huma shared a heartfelt social media post praising Rachit's journey in the film industry. In her note, Huma re-called how he moved from Banaras to Mumbai with dreams of becoming an actor. She highlighted his years of work-ing behind the scenes as an acting coach and mentor before finally stepping into the spotlight himself.

"When I first met Rachit, what struck me wasn't just his talent, it was his patience and grit... For over a decade, he has coached, mentored and trained performers who went on to be-come stars. He stood behind the camera, in rehearsals rooms and in workshops, helping others shine while quietly wait-ing for his own moment. And that's what I admire most about him. He never stopped believing that his turn would come."

Calling his success a result of

"hard work, consistency and faith in his craft", Huma welcomed him to his new phase as an actor. "This isn't an overnight success story. It's the result of years of showing up when nobody was watching. You've done the hard part al-ready. Now ... the stage is yours, Sid-dhu," she wrote.

Rachit Singh made his debut with the series Karma Calling. He was later seen in the movie Thamma, which marked his Bollywood debut. Baby Do Die Do is his second movie. Up next, he is gearing up to impress audiences in the series Welcome To Khoya Mahal.

Apart from acting, Rachit is an act-ing coach and has reportedly trained several actors, including Alia Bhatt, Ranveer Singh, Vicky Kaushal, Varun Dhawan and Anushka Sharma.

OMG 2 Producer Hits Back At Paresh Rawal Over 'Shocking' Story-Credit Claim For Akshay Kumar Film

Mumbai, 17 July: Paresh Rawal has recently claimed in an interview with Vicky Lalwani that the story that went on to become OMG 2 was his idea, which he had developed with director Amit Rai. However, the concept changed substantially when Akshay Kumar became in-volved, and thus Rawal de-cided to stay away. OMG 2 producer Ashwin Varde has now dismissed all such claims made by Paresh Rawal, calling them "shock-ing, untrue and unsubstanti-ated".

In an official statement, the producer said, "These al-legations leave me with no option but to publicly set the record straight. I would like to share my version of the journey of OMG 2, as it re-ally happened."

He continued, "I must also state that Paresh Rawal was given due credit as the PRODUCER in OMG 2, even though he had made zero contribution to it. He chose to give the credit to his wife, Swaroop Paresh Rawal, and his business partner,



from doing the same," added producer Ashwin Varde.

"I was senior actor Pavan Malhotra who first recommended writer-director Amit Rai's name to me. I had worked with Malhotra in Mubarakan, a film that I pro-duced. I met Amit for a com-pletely different film. Post

that, Amit and I became friends, and we'd often meet at his office in Bandra, Mum-bai. On one of those days, during a casual conversation, Amit briefly narrated a sub-ject to me, which stayed with me. That was the subject that eventually became OMG 2," added the producer.

Furthermore, he ex-

plained that when he had first heard it, his initial reaction was that it completely resem-bled the OMG format. It was kept similar because Paresh Rawal had insisted on the OMG 2 script staying as sim-ilar to OMG as possible.

Paresh Rawal and Amit Rai also shared a good cama-

raderie, as they had previ-ously worked together on Road to Sangam.

What Left The Pro-ducer Concerned About OMG 2

Reiterating his con-cern, Ashwin Varde said, "But I had a concern – OMG cannot be made with-out Akshay Kumar or his approval, since I was aware that the IP rights of the film belonged to him."

"Amit had asked the same question to Paresh, and Paresh had told him that the IP belonged to him (Paresh) and there was noth-ing to worry about. Though Amit still had reservations, Paresh informed him that even if OMG Part 100 had to be made, only he would write and direct it, suggest-ing that he was the film's rightful owner. That's why Amit went ahead and fin-ished his script, which is en-tirely his own. The only difference was that the char-acter of God (which was later played by Akshay Kumar) was that of a fakir," he added.
